### **Central Bank of Seychelles to administer the issue of a Development Bank of Seychelles Bond (Series3)**

As of February 28, 2011, the Domestic Debt Section of the Central Bank of Seychelles will be administering the issue of a Development Bank of Seychelles (DBS) bond. The bond to be issued on behalf of DBS will be a five year bond, earning interest of 6 %. The Bond will be available on tap issue.

Investors of the DBS bond will benefit from quarterly interest payments, commencing March 15, 2011 until maturity.

The prospectus will be published in the Seychelles Nation on Saturday, February 26 and Monday, February 28, 2011.
